The Alliance envisions a world in which children are protected from abuse, neglect, exploitation and violence in humanitarian settings.

The Alliance for Child Protection in Humanitarian Action (the Alliance) supports the efforts of humanitarian actors to achieve high quality and effective child protection interventions in humanitarian settings. Through its technical Working Groups and Task Forces, the Alliance develops inter-agency operational standards and provides technical guidance to support the work of child protection actors in humanitarian settings.

WORKING GROUPS & TASK FORCES

The four permanent work streams of the Alliance are: 1) Standard setting and guidance development; 2) Capacity building, learning and development; 3) Evidence generation and knowledge management; and 4) Advocacy. The four Working Groups correspond to the work streams and are reinforced by Task Forces that focus on specific, technical child protection issues.
